candidate has qualified, they remain eligible for sires stakes events. All eligible in qualifying races will be

subject to pre- and/or post-racing testing. Stewards' time allowance for off track will be accepted. Any

eligible on the starters list (for behavior at the gate) must re-qualify before entering any race or elimination.

DRIVERS: Please be advised USTA Rule 18.01 will be enforced.
